- 1. Call to Order: by Frank Williams at 5:34 pm. Members in attendance were Frank Williams, Bishop Chris Stokes, Nancy Brown Mr. Ed Rick, and Tara Lowe-Phillips. Also attending was Principal Kristin Walker.
- 2. Agenda for September 9, 2023: Agenda was approved 5-0
- 3. Approval of the August 8, 2023 meeting minutes: Minutes were read and approved 5-0
