-Principal's Report: Currently, 90 students are enrolled with a possibility of going up to 93 as we have 3 additional applications. The school went to McIntosh School for a First Responders Field trip and saw, and loved the helicopter land and take off. Our forensics class went on a field trip to the Escape

Room in Gainesville and had a wonderful time. We have out A/B honor roll field trip planned to the trampoline park. All new teachers are doing well. Out of class teachers are Serena Suggs in Art, Emily Conte in Public Service and Emily Conte & Lesleigh Phillips in Math 6-12. They have tests scheduled so they can meet criteria for the classes they teach. Our school guardian is fantastic. He is the only one from the last group that went through the program to get certified. Our counselor is coming once a week and is being paid for by the mental health money set aside by the Alachua County School Board. Professional Development training was held for staff that voucher Responsive Trust Based Mental Health. New FAST testing has begun and FAST Progress Monitoring 1 has been completed while FAST Progress Monitoring 2 will be held in December. The Blood drive, student flu mist and pictures day that was held at the school went well. MA's PTO president is Nancy Brown and is doing a great job. The Fall Festival the PTO had a wheelbarrow and gift card drawing and raised about \$1200. The awning on the back door is still in progress and Mr. Johnson will finish it soon. The magnetizing of the front door is slowly getting completed. K. Walker and E. Ricks went to the Charter School Conference in Orlando that was paid for by Title 2 funds. October 26th was the Charter School Principal meeting where the new Charter School lesion was introduced, Charles Strappy.
